



**SHOP, SHARE & WIN – New Year 2019 Contest** (hereinafter called the “Contest”) is operated by Courts (Malaysia) Sdn. Bhd. under the business address of No. 36, Jalan Genting Klang, Setapak, 53300 Kuala Lumpur. (hereinafter called “Courts Malaysia”)

#### **1. ELIGIBLE PARTICIPANTS**

- a. An eligible participant is an adult above the age of 18, as of 27<sup>th</sup> December 2018
